

# SECOND AMENDMENT TO BYLAWS OF

# WHITE OAK RANCH SUBDIVISION HOMEOWNERS ASSOCIATION, INC.

WHEREAS, the Bylaws of the White Oak Ranch Subdivision Homeowners Association, Inc. (herinafter Bylaws) were executed in 2001 and amended in 2010;

WHEREAS, Article XII, Section 1 of the Bylaws provide that it "may be amended, at a regular or special meeting of the Members, by a vote of a majority of a quorum present in person in person or proxy."

WHEREAS, in order to provide that newly elected Directors have the opportunity to elect officers in the first year of their terms;

WHEREAS, at a meeting of the Members, a majority of a quorum voted to amend the following provision of the Bylaws;

NOW THEREFORE, Article VIII, Section 2 is hereby amended by deleting the section in its entirety and replacing it with the following:

"Section 2. Election of Officers. The election of officers shall take place at the first meeting of the Board of Directors following January 1 of each year.

Nothing herein is intended to alter, modify or amend the Bylaws except as specifically provided hereinabove.




