

FIRST AMENDMENT TO BYLAWS OF

WHITE OAK RANCH SUBDIVISION HOMEOWNERS ASSOCIATION, INC.

WHEREAS, the Bylaws of White Oak Ranch Subdivision of Homeowners Association, Inc. (hereinafter "Bylaws") were executed in 2001;

WHEREAS, Article XII, Section 1 of the Bylaws provide that it "may be amended, at a regular or special meeting of the Members, by a vote of a majority of a quorum of Members present in person or by proxy."

WHEREAS, at a meeting of the Members, a majority of a quorum voted to amend the following provisions of the Bylaws;

NOW THEREFORE, Article IV, Section 2 is hereby amended by deleting that section in its entirety and replacing it with the following:

> "Section 2. Term of Office. The initial board of five (5) directors shall be selected by the Developer. At the annual meeting to be held in October 2011, the Members shall elect three (3) new directors for terms of two (2) years, leaving two (2) of the directors initially selected by the Developer on the board. At the annual meeting to be held in October 2012, the Members shall elect two (2) new directors for terms of two (2) years to replace the two (2) initial directors still remaining on the Board. At each annual meeting thereafter, the Members shall elect directors for terms of two (2) years as may be needed. Newly elected directors shall begin their term on January 1 following election at the annual meeting."

NOW THEREFORE, Article V, Section 2, is hereby amended by adding the following sentence to the end of the Section:

> "Ties in the election of directors will be settled by drawing numbers."

Nothing herein is intended to alter, modify or amend the Bylaws except as specifically provided hereinabove.
